## STORAGE TERMS & AGREEMENT

This storage agreement is made and entered into by and between:

and the Lake Champlain Community Sailing Center, Inc., its directors, officers, staff and agents (hereinafter referred to as "CSC").

1. Storage of any items other than the user's boat and boat accessories is prohibited by this agreement.
2. ALL PROPERTY STORED AT CSC SHALL BE AT THE USER'S SOLE RISK. User must provide his/her insurance, to include but not limited to fire and extended coverage, with theft, vandalism and malicious mischief endorsements.
3. Any insurance which may be carried by user or CSC against any loss or damage to the building, contents or other improvements on the premises shall be for the sole benefit of the party carrying such insurance and under its control. Each party hereby waives its right and the right of its insurer of subrogation against the other party.
4. User hereby agrees to indemnify CSC and hold it harmless for any loss, damage, expense or claim, including negligence by any party, arising out of user's acts or omissions to act; and CSC shall not be liable to user for any loss or damage that may be occasioned by or through the act or omission to act of other users on the premises, or of any other person.
5. User further acknowledges he/she has inspected the premises and finds it to be in satisfactory condition.
6. User agrees to abide by all rules and policies now in effect or that may be put into effect from time to time. Written rules are posted on the site and in the office.
7. The CSC reserves the right to restrict use to only wind or human powered craft with correct equipment to adapt to the CSC's launch and storage facilities.
  - There will be no day-to-day staff at the CSC during the first and last months of the season.
8. Storage includes: use of ramp and facility, combination to CSC gate locks.

## OPTIONS & PRICING

Rack space: Laser, Sunfish, Canoe, Kayak, Sailboard, etc.  
(You may fit up to two boats on your rack)

Fee: Single boat on rack.....\$200  
Each additional boat that fits on the same rack.....\$75

Ground space: Boats on pads/tires or boat on trailer

Fee: Boat 14' and under .....\$19 per foot  
Boat 15-18' .....\$20 per foot  
Boat 19' and up, tri/catamarans & motorboats.....\$21 per foot  
Each additional boat that fits in your allotted ground space.....\$75

Hoist use: Sailors must provide their own lifting equipment

Fee: One-time hoist use .....\$4 per foot  
Season hoist use.....\$8 per foot

## STORAGE DETAILS

Dates: May 13, 2017- October 31, 2017

- User’s boat and equipment must be removed by October 31, 2017.
- The CSC will apply a late fee of \$50 to any user who leaves their boat at the CSC after October 31, 2017.
- Any boats left at the center after December 1, 2017 will be charged the full winter storage rate.
